This publication provides a March 2022 submission from the Ministry of Defence informing the Minister of Defence of the decision taken by Defence to defer work on the Southern Ocean Patrol Vessel project and the intent to inform industry of this decision.

DEFERMENT OF SOUTHERN OCEAN PATROL VESSEL PROJECT

Purpose

1. To inform you of the decision taken by Defence to defer work on the Southern Ocean Patrol Vessel (SOPV) project and the intent to inform industry of this decision.

Executive Summary

- 2. Defence stood up an Integrated Project Team (IPT) in 2018 to investigate the benefit of investing in a Southern Ocean patrol capability. The Defence Capability Plan 2019 (DCP19) confirmed the need for a SOPV and an Indicative Business Case establishing the case for investment was prepared and approved by Cabinet in August 2020. In approving this business case Cabinet invited the Minister of Defence to return to Cabinet by the end of 2021 with a Detailed Business Case (DBC) identifying the preferred solution with a full analysis of the cost, operating expectations and benefits.
- 3. As part of preparing this DBC Defence issued a Request for Information (RFI) through the Government Electronic Tendering Service (GETS) in June 2021. This solicited information from industry to inform the Detailed Business Case development. \$9(2)(g)(i), \$9(2)(f)(iv)

5. DCP19 had an indicative Capital budget for the SOPV of . The Indicative Business Case indicated the probability of costs aligned with that forecast. If a DBC had been completed and submitted to Cabinet, the next stage would have been to release a tender.

6. Emerging personnel pressures from other projects and operational funding pressures within NZDF resulted in work ceasing on SOPV in August 2021 and resources being redeployed.

Comment

7. When issuing an RFI on GETS Defence receives responses from industry at no cost, despite the work that companies put into preparing their responses. Therefore, it is important that Defence treats these responses appropriately. In line with this, MBIE developed GETS

practice guides and the Defence Capability Management System (CMS) both require that a notice be placed on GETS regarding the outcome of the process as soon as practical. This has not yet taken place with regards to the SOPV RFI \$9(2)(g)(i)

8. In order to preserve Defence's relationship with industry and to maintain their interest in responded to future RFIs and tenders, we need to urgently put a notice on GETS informing industry of the decision to defer work on the SOPV project. A draft GETS notice has been prepared and is attached to this submission.

The Future of SOPV

9. The project has been deferred, not cancelled. If fiscal and other conditions were to change, the project could be resumed. We estimate that from mid-2022, a DBC would take at least 9 -12 months to produce once the project is restarted, and this would probably involve another RFI to obtain updated cost data.

Southern Ocean Presence and Surveillance

- 11. Deferring work on the SOPV project will mean the continuation of current limitations on naval patrolling in the Southern Ocean. Air patrols and surveillance by other means are continuing.
- 12. While HMNZS AOTEAROA has recently completed a successful resupply operation to the US base at McMurdo and Scott Base, as a replenishment tanker AOTEAROA is unsuitable for patrol operations.

Next Steps

- 13. Defence is planning to upload the attached GETS notice informing industry of the decision to defer work on the SOPV project, if approved by you. Defence will inform key interested Government agencies of the intent to upload this notice in advance of doing so.
- 14. Defence have prepared a set of key points for your office to use should they wish to engage with counterparts on this decision. These are also attached.

Recommendations

- 15. It is recommended that you:
 - Note that in August 2020 Cabinet approved the Southern Ocean Patrol Vessel Indicative Business Case and invited the Minister of Defence to return with a Detailed Business Case by the end of 2021;
