### PROPOSED OVERSEAS TRAVEL: HON RON MARK: Timor-Leste – 18 to 22 September 2019

### Proposal

- I seek Cabinet approval to travel to Timor-Leste as the government representative for the 20<sup>th</sup> anniversary of the establishment of the United Nations Mission in East Timor (UNAMET) and International Force East Timor (INTERFET) peacekeeping missions. A number of activities will mark the anniversary, including a commemoration, unveiling of memorial and exhibitions, veterans' parade, inauguration of monuments, and a community concert.
- 2. Ministerial representation at this significant event will acknowledge the historic and ongoing relationship between New Zealand and Timor-Leste. Electoral Observers, Foreign Affairs staff, and Military, Police, Customs and Corrections personnel served in Timor-Leste during the independence period. Timor-Leste remains an important regional security relationship. Australian representation will be at the Governor General and potentially Ministerial level.
- 3. I will be away from New Zealand from Wednesday 18 until Sunday 22 September 2019.
- 4. The Prime Minister has approved the travel in principle. The travel will occur over a sitting week, and the NZ first Caucus has approved my leave from the house.
- 5. Travel will be via commercial transport.

### TRAVEL REPORT: HON RON MARK; TIMOR-LESTE 18 – 23 SEP 2019

#### **Executive Summary**

 From 18 – 23 September I travelled to Timor-Leste as the government representative for the 20<sup>th</sup> anniversary of the International Forces East Timor (INTERFET) deployment, and to conduct bilateral engagement with my Timorese counterpart. I was accompanied by officials from the New Zealand Defence Force, and NZDF INTERFET veterans. Further detail of activities and engagements is available in formal messaging.

#### Report

- 2. On my first day in country (19 Sep) I conducted a bilateral call with the Timorese Minister of Defence, Filomeno Paixão. I had previously met Minister Paixão at the Shangri-La Dialogue in June of this year. This meeting provided us with an opportunity to deepen our engagement on areas of mutual security interest, and for me to share with Minister Paixão and his team some of the lessons that NZ Defence has learned about sustainable and effective military procurement.

During my visit the NZ Embassy unveiled a plaque on their grounds, commemorating the seven New Zealanders (one journalist, one activist, and five soldiers) that died in Timor between 1975 and 2002. This was a moving ceremony, and the families of those who died are appreciative of the opportunity to acknowledge their sacrifice, and the contribution that it made to Timor-Leste's journey to peace and independence.

- 5. The main focus of the trip were the commemorations of the INTERFET deployment. This included: visits to museums and historic sites related to the resistance struggle; a banquet dinner at the Historic Palãcio de Lahane; a military parade and dedication of the INTERFET memorial plaque; an official parade through the city (with the public joining in); a friendship lunch hosted by Nobel Peace Prize Laureate José Ramos-Horta; and commemorative football matches between the Falintil and INTERFET veterans, and then the current F-FDTL and Australian Defence Force teams. In acknowledgement of NZ's role as the second largest contributing nation to INTERFET, I laid a wreath at the dedication of the plaque, and there was a special acknowledgement of Major General (retired) Martyn Dunne.

The participation of cultural groups, including children's groups, in the events was especially touching.

During my visit I was able to engage with senior Timorese leaders President Dr Fransisco Guterres (popularly known by his nom de guerre Lu Olo) Prime Minister José Maria Vasconcelos (Taur Matan Ruak), former Prime Minister and President Kay Rala Xanana Gusmao (who made a star turn as the goal keeper in the commemorative football match), and José Ramos-Horta. General the Honourable Sir Peter Cosgrove, Commander of the multi-national INTERFET deployment was an honoured guest throughout.
- 8. During my visit I also had the opportunity to meet again with my Australian counterparts, Minister of Defence Senator the Hon Linda Reynolds, and Minister for Veterans and Defence Personnel the Hon Darren Chester. Minister Reynolds hosted an INTERFET Reception on board HMAS Choules, a Royal Australian Navy landing ship which was part way through a Pacific tour.

### Summary

9. This visit was very effective in establishing furthering our bilateral relationship with Timor-Leste, and demonstrating support in her ambitions for security and economic independence. The presence of the NZ delegation was greatly appreciated by our hosts, and the veterans who attended valued the opportunity to visit an increasingly confident and flourishing Timor, and reflect on their experiences during the INTERFET deployment.
