- 4 **noted** that he will be accompanied by officials from the Ministry of Defence and the New Zealand Defence Force, whose costs will be met by their respective agencies;
- agreed that in his absence the Rt Hon Winston Peters act as Minister of Defence and Minister for Veterans;
- 6 **noted** that the House is not sitting during his absence.

- 3. In addition to meeting with General Wei, I also propose to meet with the Vice Chairman of the Central Military Commission, General Zhang Youxia. China is organising a visit to a regional command, probably Xian.
- 4. Overall, the visit would enable me to deepen my understanding of China and will provide an opportunity for Minister Wei and me to sign the Memorandum on Defence Cooperation.
- 5. I will be away from New Zealand from Sunday 30 June until Friday 5 July 2019.
- 6. The Prime Minister has approved the travel in principle. The travel will occur over a recess week.
- 7. Travel will be via commercial transport.

8. I propose to travel with one staff member from my office, and will be accompanied by officials from the Ministry of Defence and the New Zealand Defence Force.

TRAVEL REPORT: HON RON MARK; CHINA 30 JUN - 5 JUL 2019

Executive Summary

4 Defence 1. From 30 June – 5 July 2019 I travelled to China to conduct bilateral engagements. I was accompanied by officials from the Ministry of Defence and New Zealand Defence Force. This was my first visit to China, with the previous visit of a Minister of Defence conducted by Hon Gerry Brownlee in 2015. During this visit I also signed the New Zealand - China Memorandum of Arrangement concerning Defence Cooperation.

Report

- 2. My first formal engagement was a speech to the 'Dragon Course' of future Peoples Liberation Army (PLA) leaders at the National Defence University. This provided me with an opportunity to reinforce the importance of transparency in defence policies and actions, being a credible and trusted partner, and the New Zealand values which guide our actions at home and abroad. My speech has been released and is available on the Beehive website. The speech was well received, and during the question and answer there was particular interest in how much we saw ourselves supporting US activities goals in the region, and in our position on the South China Sea territorial disputes.
- 3. My key bilateral engagement was with my counterpart, General Wei Fenghe, Minister of National Defense. Minister of National Defense.

- 5. At the conclusion of our meeting General Wei and I signed the New Zealand China Memorandum of Arrangement concerning Defence Cooperation. This non-binding MOA does not commit Defence to specific new activities but sets out the intent to maintain dialogue and recognises potential areas of common interest such as humanitarian assistance and disaster relief, counter terrorism, and maritime security. It is supported by a previously developed five year plantand annual plan of activities and engagements. The MOA has been released and is available on the Beehive website.
- 6. While in Beijing I also conducted a courtesy call with General Xu Quilang, Member of the Political Bureau of the Central Committee of the Communist Party, and Vice Chairman of the Central Military Committee. This was a very warm and productive engagement. I also conducts visits to a PLA guard unit, the Forbidden City and Great Wall. Chief of Defence Force NZDF, Air Marshal Kevin Short, conducted a call with his counterpart, General Li Zuocheng.
- 7. The second part of my visit was in Xi'an, in Shaanxi Province. While in Xi'an I was hosted by Major General Li Yang, Political Commissar of Shaanxi Provincial Military Region. This visit included a bilateral meeting,

 at the Northwestern Polytechnical University, and a visit to the Xi'an City Wall and the Terracotta Warriors. The focus for this portion of the visit was on understanding Chinese cultural and historical context.
- 8. My next engagement with my counterpart, General Wei, will be at the ADDMM+ in Thailand in November. Defence officials will attend the Xiangshan regional security Forum in Beijing in December.
